LCL Quality Statement

Liverpool Clinical Laboratories is the largest pathology service provider in Cheshire and Merseyside, formed in 2013 from the amalgamation of the pathology clinical services and laboratories of the Aintree University Hospital NHS Foundation Trust and the Royal Liverpool and Broadgreen University Hospitals NHS Trust. As of October 2019, Aintree and The Royal have merged to become Liverpool University Hospitals NHS Foundation Trust.

LCL primarily work on the diagnosis of disease and evaluate the effectiveness of treatments and undertake research into the causes and cures of disease, processing over 5 million samples, generating approx. 15 million tests results each year.

LCL provides specialist clinical laboratory services, regionally and nationally, meeting the needs of acute, primary and specialist healthcare providers. The clinical laboratories cover the main disciplines of:

- Blood Sciences: Biochemistry, Blood and Marrow Transplantation, Haematology, and Transfusion Science.
- Cellular Pathology: Histopathology, Cytology, Immunocytochemistry, Molecular Pathology, National Specialist Ophthalmic Pathology Service Mortuary and Bereavement Services.
- Infection and Immunity: Medical Microbiology, Virology, Immunology and Histocompatibility and Immunogenetics.
- Haemato-Oncology Diagnostic Service (HODS)
- Other services including: Phlebotomy and Point of Care Testing.
